4a (Code:) (Expenses \$ 1,107,582 including grants of \$) (Revenue \$) FOOD & NUTRITION SERVICES: From January-December 2021, IH provided 12,363 meals in the form of hot/cold lunches in our weekly congregate meals program. IH also provided 60,822 meals from 6,758 pantry bags, and 125,272 meals from 17,896 fresh market produce bags while serving over 150 PLWHA clients and 4,082 community members in our Central/East Harlem + South Bronx community fresh market initiative; as well, we distributed 388 food vouchers (value at an average \$75 per voucher) to 58 PLWHA providing them with 9,708 meals in total. 6,758 emergency pantry bags were distributed to over 1,889 community clients. IH also conducted 38 nutrition health workshops with 313 duplicated PLWHA participants + 35 cooking class series, and 36 healthy movement fitness classes with more than 1,658 duplicated participants.

4b (Code:) (Expenses \$ 4,866,086 including grants of \$) (Revenue \$) HOUSING PROGRAMS: SSHP1 During 2021 services were provided for 60 clients in SSHP1 totaling 1,641 services (41 Black clients, 15 Latin clients, 2 White clients, and clients identified as other totaled 2). There were 22 female clients, 37 male clients, and 1 trans-female. Four clients were employed, and one client attended graduate school (Masters in English at CUNY). SSHP2 During 2021 supportive case management services were provided to 17 clients, totaling 406 services (9 Black clients, 6 Latin clients, and 2 White clients). There were 7 female clients and 10 males. There were no clients in SSHP2 who were employed or in school. SSHP 3 provided a total of 1614 services to 39 clients: 27 males and 12 females. HOPWA provided a total of 2378 to 41 clients: 21 males, 18 females and 2 transgender (male to female). Through the case management program, 11 clients are employed, 3 are enrolled in school, and one is in job training.

4c (Code:) (Expenses \$ 2,461,725 including grants of \$) (Revenue \$) PREVENTION: One support group reached 21 HIV negative women, 32 prevention education workshops were completed with 160 participants, 26 individuals attended CLEAR, 24 women living with HIV participated in WILLOW, 117 emotional wellness sessions were conducted, 18 faith-based workshops with 286 participates were completed, 21 women participated in Healthy Relationships, and 24 Love Your Life support groups with 217 participants were also completed. We administered 1,295 HIV tests with a sero-positivity rate of 1.00%, 307 gonorrhea screenings with a sero-positivity rate of 1.95%, 398 syphilis screenings with a sero-positivity rate of 1.76%, 308 chlamydia screenings a sero-positivity rate of 3.89%, and 726 Hepatitis C tests with a sero-positivity rate of .74%. Iris House ETE efforts included 99 outreach events reaching 5,780 individuals, distributed 243,382 condoms (224,452 male condoms and 18,932 female condoms) and 198,645 packets of lubricants, and offered PrEP-PEP education to 113 persons.
